Qualification criteria for the consultants will be based on the applicant's knowledge, skills and expertise and experiences on urban planning and city developmental issues, availability of experts and professional staff. The company working in the form of a think-tank on city development will be given priority than engineering consulting firms.

# Objective of Consultancy Services or Brief TOR

#### **BACK GROUND**

Nepal's urbanization process is rapid, haphazard and unmanaged compared to regional context. Large cities are failing to cope with the demand of infrastructure services and job opportunities and are increasingly reeling under the externalities of the haphazard urbanization. Environmental degradation, congestion, urban poverty, squatter settlements, unemployment and lagging provisions of infrastructure services have become increasingly visible phenomenon in these large cities. Hence, much of the economic gains acquired from urbanization have been eroded from its negative externalities. Urban centers in the country have yet to emerge as the engines of economic growth and contribute to reduction of urban or rural poverty alike.

Most of the cities are seeking to develop their cities on a sustainable way with a long-term vision and goals. For making cities well-planned, well-designed and developed systematically, the city needs to know where the city is, the present situation of the city in terms of strength, weakness, opportunities, constraints, challenges and threats. In this regard, the city needs to make its overall profile and carry out detail mapping of resources. This will guide the city planners and administrators to plan their cities.

#### **OBJECTIVES**

The main objective of the proposed assignment is to prepare Municipal Profile & Resource Mapof a Rural Municipality:

The other objectives are as follows:

- Prepare different theme based Resource Maps and ultimately a Municipal Database of resources.
- To identify and map out the current, past and ongoing projects in the municipal area.
- Perform detailed survey and data collection
- Locate and Survey other entities like Schools, Local business, religious sites etc. and prepare a Municipal database including all these utilities and urban structures.

#### **EXPECTED OUTPUT**

The complete project shall include but not necessarily limited to the followings:

- 1) Municipality profile: An up to-date municipality profile will be prepared, comprising of base- line information of the existing physical, social, economic, demographic, environment, financial andorganizational state of the municipality. Apart from the key statistics, such base line information will also include textual descriptions, maps, charts, diagram, and key problems prevailing in the settlements and the municipality.
- 2)
  Analysis: The section contains at least of the followings:

Trend analysis: The analysis will reveal among other things growth trend of—population, migration, land use, infrastructure provisions, import-export of goods, agricultural outputs, jobs, and other economic opportunities of last 10 years.

SWOT analysis: This will reveal potentiality of the municipality based on its strength and opportunities. The analysis will also reveal the weaker side of the municipality, which tends to pose threat to the future development of the municipality.

Spatial analysis: The analysis will clearly reveal demand and supply situation of vacant land, besides including land develop-ability analysis. The analysis, therefore, will clearly show the location where the future growth can be channelized.

Financial analysis: The analysis will reveal income potential (revenue and non revenue) and financing sources including expenditure pattern of the municipality for the past recent years and forecast for the future.

#### PREPARATION OF URBAN BASE MAP

The Base map will include the following:

- GIS based base map including: existing streets, building footprints with building use, occupancy and general demographics based on the latest archive satellite image.
- · Population density and growth rate
- Existing land use (housing, commercial, industrial, agricultural, natural, mixed use, guthi land, public space, squatted land)
- Slope and watershed analysis
- Transportation (roads with classification national highways, feeder roads, district roads and urban roads (administrative classification), Parking space, bus park, public transportation routes,frequencies and stops, airport and destinations)
- Water supply, sewerage system (sewerage network, discharge points, treatment plant if any).

- Solid waste (coverage of public and private collection system, formal and informal waste management sites, recycling points).
- Electricity (production and transportation infrastructure, grid power coverage, street lighting)
- Public services (health, education, police, rescue services, cemeteries, administrative services.....)
- Environment (erosion, pollution, forest, water bodies)
- Culture and tourism (temples, museums, cinemas, views, monuments, performance places, festival routes)

#### **METHODS**

Data Gathering And Analysis

Plan preparation will rely on both primary and secondary data. Primary data especially related to land use pattern, existing road networks their standards and quality, Drainage, sewerage network environment problems etc. will be gathered through physical mapping using GIS/ cadastral map, on the site observation, technical investigation and interview.

The acts, rules, regulation, policies, norms, standards and guidelines related to urban development / land development or practices will be followed. Collection of all relevant documents, literatures will be done.

Municipal level problems and needs will be ascertained through Participatory Rapid Appraisal (PRA), opinion survey of prominent citizens, people, officials of the local and government agencies, and through the municipal level meetings, as well as representative of each wards of municipality.

Data on physical, environmental, social, economic, financial, and institutional will be gathered from sources such as office records or archives, municipal reports/ profile, published academic or professional reports, and data published by CBS. Analysis will include both trend, spatial analysis using GIS, and interpretation of aerial photographs and digital survey.
